Thank you for your e-mail. We cannot agree to your conditions of making Judd's recording available only after obtaining authorization from the Judd Foundation. Let me explain our intentions once again because you might have misunderstood a message I sent on October 26.

As part of Marysia Lewandowska's art residency at the Center for Curatorial Studies at Bard College, we are planning to release the recordings from the Women's Audio Archive, which was created by Lewandowska between 1983-1990, into the public domain via a dedicated website. It is not Bard College website but special art website dedicated to the archive. However there will be information about this project at Bard College website and link to the on-line archive.

We want to share Judd's recording without barring access to it. Through the WAA we are pleased to make knowledge accessible as a public good without unnecessary restrictions or limitations.

There is no commercial aspect attached to our project and the question of original recording doesn't really matter, because it is neither a sound art, nor an edition of an artwork. In a way, as Judd's lecture had an art educational and public intention, our project is conceived in the same spirit.

Of course we will send a copy of the recording to Donald Judd Foundation, but since we hope to publish it on-line, everyone will be able to access it freely. It is not only our intention but also Donald Judd's Foundation one to make this outstanding recording available.

At the moment no one else besides us has the opportunity to listen to the recording. I look forward to your reconsidered response.
